To vote for any candidate for COUNTY COUNCIL AT-LARGE you must make another voting mark for each candidate you wish to vote for. Your straight party vote will not count as a vote for any candidate for that office. If you wish to vote for a candidate seeking a nonpartisan office or on a public question you must make another voting mark in the appropriate box on the ballot.
To vote for a write-in candidate, completely fill in the box provided to the left of the words "Write-In" and write in the name of the candidate on the line provided. A write-in vote will not be counted unless the vote is for a declared write-in candidate.
